

TARIFFS: RECREATION TRUST FACILITIES

The Virgin Islands Recreation Trust, according to the Recreation Trust Ordinance 1966 is a Statutory Body, entrusted with the oversight of public recreation grounds and other recreational facilities that meet the needs of the community. TO assist with the maintenance of these facilities, the Trust will raise funds via the application of fees for their use.

The various facilities entrusted to the Recreation Trust can be categorized as Parks, Recreation Grounds, and Gymnasiums. Depending on the event and the type of organization contracting to use the facilities, a fee shall be charged a daily rate as follows:
